SCOPE OF WORK & REQUIREMENTS

- 1. To conduct Secretarial Audit of AAICLAS for the financial year 2023-24, 2024-25 and 2025-2026 and verify all the documents such as Minutes book, registers, resolutions, etc. as per the Companies Act, 2013.
- To certify that the company is complying all the applicable provisions of Companies Act, 2013 and submit FORM MR-3 (Secretarial Audit Report) to the AAICLAS Board and to the Members of AAICLAS.

 - a. Rate quoted should be exclusive of GST/statutory taxes, if any.
 - b. GST & other statutory taxes, as applicable (if any) shall be paid extra by AAICLAS.

4. Eligibility Criteria:

- i. PCS/Firm should have Office based in Delhi/NCR.
- ii. PCS/Firm should have a total experience of at least 2 years as on 30.06.2024 from the date of issuance of Certificate of Practice by Institute of Company Secretaries of India.

5. Place of Audit:

The audit work has to be conducted at the Corporate Office of the Company at AAICLAS, AAICLAS Complex, Delhi Flying Club Road, Safdarjung Airport, New Delhi – 110003.

6. Selection Criteria:

Payment shall be released in 3 equal instalments, shall be paid every year within one month from (i) the date of convening the Annual General Meeting (AGM) of AAICLAS for that financial year or (ii) the date of submission of bill by the PCS/Firm to the Company, whichever is later. No advance payment shall be made for conduct of Secretarial Audit.

- 3. **Rejection of offer/Cancellation of contract:** If the bidder firm/organization gives wrong information in its offer, AAICLAS reserves the right to reject such offer at any stage or to cancel the contract, if awarded.
